

Where is the conference located?

I registered late; will I get a badge?

Badges can be printed on-site for late registrants. Please visit the registration desk

I plan to drive to the conference, what are the parking instructions if I AM staying at the hotel?

Guests will need to park in Beaubien Garage, located on Beaubien Street, and charge to their guest room. Beaubien also offers in and out privileges using the guest room key. Once inside Beaubien Garage, utilize the skyway on the 2nd level of the garage to access the Renaissance Center. Follow the signs to the Marriott guest elevators to access the 3rd floor, where the lobby is located.

Guests arriving after 11pm from Beaubien will need to utilize the circular walkway towards the Marriott Motor Lobby. From there, they will take the elevators in the Motor Lobby to the main lobby.

Please notify the front desk at check-in that they have parked a vehicle in Beaubien Garage. Upon check out, please hold on to your room key, as you'll need this to exit the garage.

I plan to drive to the conference, what are the parking instructions if I am NOT staying at the hotel?

Guests will need to park in Beaubien Garage, located on Beaubien Street. Once inside Beaubien Garage, utilize the skyway on the 2nd level of the garage to access the Renaissance Center. Follow the signs to the Marriott guest elevators to access the 3rd floor, where the lobby is located.

What is the deadline for CLE reporting?

The deadline for reporting EJC 2024 CLE credit is Monday, May 13th. Please ensure that you have claimed CLE for each session you attended in the [CLE portal](#) by the **close of business on Monday, May 13th**. If you have any technical issues, please email learninglab@nlada.org.

Will I receive one certificate including all my CLE credits from the conference?

Unlike previous systems, you will not receive one certificate for the overall conference. You will receive an individual certificate for **each** session you attend, which will be totaled for reporting if you are from a state where NLADA does this on your behalf.

You can view all your certificates by navigating to Dashboard on the right-hand side and then “Transcript /Achievements”. Here you can view your certificates per session and the requested CLE credits, including any specialty credits.

How do I know if NLADA will apply on my behalf?

NLADA will report attendance to the states below; we will update approval codes as we receive them.

If your state is not listed, you can still self-apply using your CLE certificates found in your dashboard on the Learning Lab.
